1. Introduction

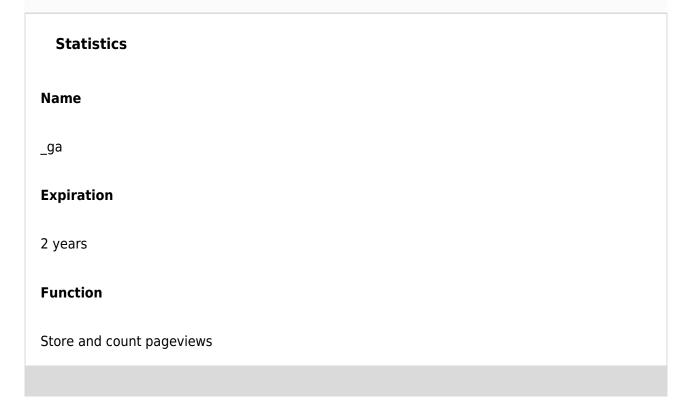
